#### Subject of the Contract

The subject of performance of the contract for providing of practical teaching (hereinafter referred to as the "Contract") is the employer's obligation for providing to students of School, listed in Annex no. 1 of this agreement, practical teaching in accordance with the conditions specified in Act No. 61/2015 coll. on Vocational Education and Training and on amendments to certain Acts (hereinafter referred to as the "Act"), at the Pinija Hotel's workplace.

### IV.

#### Form of practical teaching

1. Practical training will be provided by the hotel Pinija in the study fields as a cook, waiter, confectioner, cosmetician within the meaning of § 3, Decree of the Ministry of Education, Youth and Sports no. 65/2015 coll. about Secondary schools.

2. The student at practical training will be performing productive work. Productive work is performed by providing services or performing of work activities, corresponding to the profession, group of occupations or professional activities for which is student preparing in the relevant study / training field.

#### **V.**

##### **Timetable of practical teaching**

1. Practical teaching will be provided by Pinija Hotel according to the timetable of practical teaching from 15.6. to 30.6. of calendar year and from 1.9. to 31.10. of calendar year, always one calendar week (7 days) for 4 to 6 students of SOŠ Senica. Each student will work 6 hours (student of the first year) or 7 hours (student of the higher grade and student of the superstructure).

#### **VI.**

##### **Start and end of practical teaching**

1. Practical teaching begins and ends on the day according to the timetable of practical lessons for the given school year. This timetable will form part of the contract, annex no. 2. It will vary according to each years.

#### **VII.**

##### **Number of students attending practical teaching**

1. The employer will provide practical teaching to the students of the School according to the list, which will be submitted to the Pinija Hotel a week prior to the arrival of students.
2. The place of practical teaching is the workplace of practical teaching - hotel Pinija.
3. Each student must provide written consent of the legal representative with the practical training at the Pinija hotel and with the conditions of execution at the Pinija Hotel. (Annex No. 5)

#### **VIII.**

##### **Number of instructors and number of pedagogical supervision of students**

1. Practical teaching will be at the Pinija hotel under the guidance of an instructor.
2. Practical teaching at the Pinija hotel's workplace can be carried out by four or six students under one instructor. The number and list of instructors who are employees of the Pinija hotel and under which the students will carry out practical training are listed in annex 3, which is an integral part of this contract.
3. The name of the school's pedagogical staff will be announced to the Pinija hotel no later than one week before the start together with the list of students.

## **IX.**

### **Material provision of the student**

1. The employer shall provide to the student, at his own expense, with material provision in accordance with § 26 of the Act and according to the Employer's Directive on the award of material and financial security.
2. The employer shall provide material security to the student in the manner specified in annex no. 7 of this Contract, which is an integral part of this Contract.

## **X.**

### **Financial provision of practical teaching at the Pinija hotel**

1. Hotel Pinija will provide a full-board meal (breakfast, lunch, dinner), drinking regime and accommodation for free. The same will be provided to one member of pedagogical supervision of the students. Once per week, the Pinija Hotel will provide accommodation, dinner and breakfast to the School driver, who will bring students to practical training for the next week and will take the students from the previous week home. Working clothes will be brought by a student from his school.
2. The students will not receive financial reward for their work, the costs will be covered by accommodation and boarding costs and pedagogical supervision.
3. Insurance for students (accident insurance, travel insurance, damage caused to the inventory, raw materials) will be paid by the School prior to the arrival of students to the Pinija hotel. (annex no. 6).

## **XI.**

### **Provisions for ensuring health and safety in the practical teaching and regulation of mutual rights**

1. Hotel Pinija is obliged to ensure that practical training will be carried out:
  - a) in accordance with the established organization of education and training at secondary schools,
  - b) productive work that corresponds to the profession, group of occupations or professional activities for which the student is being trained, and
  - c) under the guidance of an instructor.
2. The employer is obliged to provide a system of control of the student's activity in practical teaching.
3. The employer is obliged to provide the material and technical conditions for carrying out the practical teaching.
4. The student is required to take part in practical teaching under the guidance of an instructor.
5. During the practical teaching, the student carries out productive work that corresponds to the profession, group of occupations or professional activities for which the student is preparing, acquires new techniques and innovative working methods, protects the name of Pinija hotel, adheres to the work discipline, is obligated to follow the instructions of the instructor and of the other management staff, treats material, working tools, machines and tools gently and does not harm the deliberate working environment.

6. During the practical teaching, the student has the rights and obligations of the employee in the field of health and safety at work laid down pursuant to § 25 par. 5 of the Act.

7. If a student, during the practical teaching, causes damage and does not remove the damage by bringing it to the previous state, the Pinija hotel may claim damages from the student. Damage compensation may not exceed in an individual student amount equal to four times the minimum wage according to pursuant § 25 sect. 4 of the Act.

## **XII.**

### **The way to terminate a contractual relationship**

1. Before the expiry of the period for which the contract was concluded, it may be terminated:
  - (a) by mutual agreement of the School and Pinija hotel;
  - (b) by a written notice from the School or the Pinija hotel for notice period at least one month.
2. If the Contract has been terminated, the School shall notify the founder in writing of this fact.

## **XIII.**

### **Final provisions**

1. This contract is concluded for a limited period of time – i.e. school year 2017/2018 from 1.9.2017 to 30.06.2018, valid for the whole time of preparation of students from the first to fourth year and the extended study / superstructure.
2. The school shall provide a copy of the contract to its founder.
3. The Contract shall enter into force and become effective on the date of signature by both Contracting parties.
4. Changes in the content of the contract may be made only by means of a written amendment, with the agreement of both parties, signed by both parties of the contract.
5. The Contract is drawn up in four originals, each of the contracting parties will receive one copy.
6. The contentious issues arisen during the practical training of students will be addressed by the representatives of both parties, in particular by agreement.
