Čl. I.

1. Poskytovateľ poskytne prijímateľovi účelovú dotáciu v zmysle § 8 zákona č. 583/2004 Z. z. o rozpočtových pravidlách územnej samosprávy a o zmene a doplnení niektorých zákonov v znení neskorších predpisov, VZN č. 7/2006 o poskytovaní dotácií z rozpočtu TTSK v znení Dodatku č. 1 k VZN o poskytovaní dotácií z rozpočtu TTSK a Výzvy TTSK č. 3/2013 na predkladanie žiadostí o dotáciu v rámci programu: „Podpora aktivít zameraných na pomoc pre sociálne odkázaných občanov“.
2. Prijímateľ sa zaväzuje poskytnutú účelovú dotáciu použiť na realizáciu projektu: **„Pomáhať je COOL“**.

Čl. II.

1. Poskytovateľ poskytne účelovú dotáciu prijímateľovi vo výške **300 €** (slovom tristo eur) na bežné výdavky.
2. Poskytovateľ poskytne účelovú dotáciu prijímateľovi po realizácii projektu a preverení predloženého vyúčtovania dotácie podľa čl. IV. písm. b) tejto zmluvy bez zbytočného zdržania najneskôr do 09.12.2013.

Čl. III.

Pre potreby a účel tejto zmluvy vymedzujú zmluvné strany pojem „účelová dotácia“ ako dotáciu určenú na úhradu oprávnených bežných výdavkov poskytnutých v zmysle Výzvy TTSK č. 3/2013 vynaložených na realizáciu projektu **„Pomáhať je COOL“**.

Použitie finančných prostriedkov na iný než dohodnutý účel je považované za porušenie finančnej disciplíny v zmysle § 31 zákona č. 523/2004 Z. z. o rozpočtových pravidlách verejnej správy a o zmene a doplnení niektorých zákonov.

Čl. IV.

Prijímateľ je povinný :

- a) použiť poskytnutú dotáciu len na účel dohodnutý v tejto zmluve,
- b) predložiť zúčtovanie dotácie a správu o vyhodnotení realizácie projektu na prílohe, ktorá tvorí neoddeliteľnú súčasť tejto zmluvy do 09.12.2013.

Čl. V.

Prijímateľ sa zaväzuje v príslušných propagačných materiáloch a na viditeľnom mieste spojenom s realizáciou projektu umiestniť logo Trnavského samosprávneho kraja a zverejniť informáciu, že projekt sa realizuje s finančnou podporou Trnavského samosprávneho kraja. Logo sa nachádza na internetovej stránke TTSK „www.trnava-vuc.sk“ – symboly.

Čl. VI.

Zmluva nadobúda platnosť dňom podpisu oboma zmluvnými stranami a účinnosť dňom nasledujúcim po dni jej zverejnenia.

Zmluva je vyhotovená v troch vyhotoveniach, pričom poskytovateľ obdrží dve vyhotovenia a prijímateľ jedno vyhotovenie.

Zmluvné strany prehlasujú, že so zmluvou sa dôkladne oboznámili, že jej porozumeli a potvrdzujú, že s ňou súhlasia a že ju uzatvárajú dobrovoľne a bez nátlaku, čo deklarujú svojimi podpismi.
