## **MEMORANDUM OF UNDERSTANDING**

between

**Uzhhorod National University, Ukraine**

hereafter referred to as the "Participants",

Wishing to develop bilateral cooperation regarding academic and cultural exchanges and scientific research activities, within the competence of the Participants,

Being aware that any cooperation activities must be conducted strictly in accordance with the respective law,

Have agreed as follows:

### **SECTION I**

The objective of this Memorandum of Understanding, hereafter referred to as "the Memorandum" is to define the scope of the bilateral cooperation.

The bilateral cooperation will refer to:

1. scientific research and joint research activities;
2. participation in seminars and academic meetings;
3. special short- and long term academic Programmes.

in domains relevant to both Participants' activities.

### **SECTION II**

Bilateral cooperation of the Participants may include, but not be limited to, the following forms:

- 1) implementation of joint research activities (joint research projects, exhibitions, organization of internships, "round tables", conferences, symposia, seminars);
- 2) exchange of information about seminars, scientific meetings, workshops, etc., organized by one of the Participants;
- 3) common organisation of events listed in par. 4 of this Section, with a possible participation of other institutions;

- 4) an exchange of academic and research related materials (i. a. articles, publications); while implementing this provision no classified information shall be exchanged;
- 5) any other activities as mutually agreed by the Participants.

### **SECTION III**

In implementing of activities under this Memorandum each Participant shall born all costs related to its representatives, unless otherwise agreed.

However, when either Participant invites guest speakers or lecturers from another Participant, costs of travelling, accommodation or board shall be borne by inviting Participant.

### **SECTION IV**

This Memorandum shall enter into force on the date of signing and shall remain in force for an unlimited period unless it is terminated in accordance with provisions below.

This Memorandum may be terminated at any time by mutual written consent signed by both Participants. It may be also terminated by either Participant in a written notice given at least six months prior to an intended withdrawal from this Memorandum.

This Memorandum may be amended at any time by mutual written consent signed by both Participants. Such amendments, once approved by both Participants, shall become a part of this Memorandum.

### **SECTION V**

The Memorandum is done in four duplicates.

UzhNU designates herewith PhD Olesia Benchak (Vice dean in international relations at the Faculty of History and International Relations) as Coordinator and contact person with regard to the initial implementation of the present MoU.
